Results from any procedure are never guaranteed. For a nominal fee, a yearly color refresher will keep the procedure area looking fresh and new. _____

Tissue heals at different levels, some people heal within 5-7 days, and some may take 10+ days to heal. _____

The procedure area may be red, swollen or have a discharge of lymph (clear fluid) and blood for at least 12+ hours post procedure. This is normal. You may apply ice for 10 minutes "on" / 10 minutes "off" to the area to reduce swelling. _____

The procedure area will be much darker for 5-7 days post procedure. After the skin sloughs off the procedure area, a softer colour will be noticeable. The true color will not be visible for 4-6 weeks post procedure and for each colour refresher. _____

All procedures may require at least 1 follow-up colour refresher session. _____

This procedure is a tattoo and everyone's pain tolerance is different. Some say the procedure is like waxing their underarms and others say it is like electrolysis. Some say tweezing their brows hurts more than a permanent cosmetic procedure. _____

If I have ever had a cold sore, I must be on an antiviral medication for at least 7 days prior to my lip procedure. _____

I will follow all after-care instructions that my technician gives me. I will not use products that are not directly given to me by the technician. _____

I ACCEPT FULL RESPONSIBILITY FOR MY PROCEDURES. IF I MOVE DURING THE PROCEDURE, I AM RESPONSIBLE FOR THE MISTAKES...NOT THE TECHNICIAN. _____

Using AHA or any skin lightening or exfoliating product on or around my procedure area will compromise the procedure and I accept responsibility for fading and future colour refreshers. _____

Eyebrows are SISTERS NOT TWINS. They will never be perfect because of muscle, tissue, and bone formation of the forehead. We will make them as symmetrical as possible. I do not expect miracles. _____

Lip colour is generally not applied outside of the lip line. All applications are to make me look like I have natural beautiful lips and not like I am wearing heavy makeup. If there is any uneven pigmentation in my lips (blue, brown or darker spots), these darker areas will pull "darker" colour and my lip colour may look uneven. _____

If I cannot tolerate the procedure and the technician cannot finish the procedure, I will be charged a \$100.00 set-up fee. _____

If the technician and I are not in full agreement with the shape of the eyebrows, lips, or eyeliner, my procedure will not be performed. _____

This establishment has a 'No Refund Policy' and I am aware of this. _____

If I pick at the crusting tissue in my procedure area, my pigment will be lost in that area making my procedure uneven and I will be required to pay for my touchup. _____

Permanent makeup procedures will not fix my life problems. _____

Cancellation Policy: I will give a 24 hour notice for any cancellation, otherwise my credit card will be charged for half of the quoted original procedure amount. _____

Prior Permanent Makeup: If I have had permanent makeup applied previously, the technician will not be held responsible for colour inconsistency, fading, or any other problem relating to the new procedure. _____

Prior Permanent Makeup: My procedure is not considered a "Touch Up" for the new technician. The technician does not know what pigments were used, if the needle was disposed of properly, if cross-contamination occurred, or any other hazardous behavior was displayed. Full price fees will be charged for each procedure. _____

I have answered honestly on my medical history forms and Informed Consent procedure forms. Noncompliance with these questions will compromise my results. _____
